Persons seeking a position in the church as a paid employee will be required to complete an employment application in addition to this Confidential Screening Form.

I understand that any material misrepresentation or omission on this form constitutes good cause for FBCG to terminate either my paid employment or involvement with the supervision or custody of minors.
